Confined Space Entry: Designed for municipal water, wastewater and storm water utility employees. Identifies and addresses common city and county permit-required confined space situations rarely covered by other programs, and details safe work practices for most types of municipal confined space entry situations.

Excavating Safety (Competent Person): Designed specifically for municipal water, wastewater, storm water utility and public works employees. Identifies and addresses common excavating hazards and details protective measures and safe work practices for all phases of the excavating job.

Lock-out/Tag-out (Control of Hazardous Energy): Reviews a recent history of public sector lock-out tag-out hazards and common accidents. Reviews as case studies various incidents applicable to 1910.147(a)(1)(i), the standard that covers the "servicing and maintenance of machines and equipment in which the unexpected "energization" or start-up of the machines or equipment, or release of stored energy, could cause injury to employees."

Water/Wastewater Utility Chemical Safety: A total chemical management approach is applied referencing GHS (Globally Harmonized System) Federal HazCom Standard 1910 Subpart H and 1910.120, requiring specific management practices, the compilation of a chemical inventory and collection and indexing of safety data sheets (SDS).

Electrical Safety: Course material covers general electrical maintenance safety, combining the principles of electrical safety, lock-out/tag-out, and worksite safety protective equipment.

Heavy Equipment Operations and Safety: Classroom and hands-on!

Water Utility Vehicle Operations: Designed specifically for municipal public works, water or wastewater utility workers and all other city, county or special district employees not in public safety divisions. This program is for good drivers as well as drivers in need of improvement.

Water Utility Storm Preparations & Recovery: Discusses department-level preparedness and reviews list of activities performed on a calendar basis and a timeline basis once an emergency is declared. Detailed activities include items that are critical as storms approach, pass over and exit the community. Many additional activities are detailed related to initiating and completing the recovery process.
